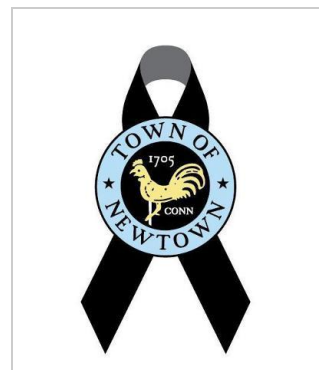

**CP-USA STRONGLY SUPPORTS CALLS FOR  
NEW, STRICTER, MORE SENSIBLE AND MORE  
COMPREHENSIVE GUN LICENSING AND CONTROL LAWS**



The news of the murder of so many innocent children in Connecticut is truly heart-breaking and almost too inconceivable to fully comprehend. Sadly my personal belief is that it took a confluence of unfortunate circumstances to result in this horror, rather than a single, simple, cause for blame. I also believe the time is long overdue for everyone to DEMAND of our City, State and National officials some SIGNIFICANT changes immediately to hopefully prevent or limit another such incident, but like so many things in life it will require EACH of us to do our part by getting involved and not merely expect someone else to resolve this problem for us, or blame someone else when nothing happens.

I personally believe we need to:

1. Require extensive background checks on all persons wishing to purchase a firearm, whether from a public dealer or a private seller, which the purchaser must pay for. This MUST include an extensive Federal criminal records check, a mental health clearance, and national courts checks to ensure no stay away or restraining orders are in place against the purchaser.
2. Require all firearm purchasers to go through a training and certification course in order to obtain and retain a firearm of any type. This will include general handling, safety, cleaning and storage, legal obligations and responsibilities. All firearm owners must re-certify every five years or surrender their firearms within five days of their certification expiring.
3. Require all firearms to be registered in a National database with the equivalent of a "pink slip" to follow the weapon every time it changes hands. Seller and purchaser must notify the national authority within five days of sale/purchase or face a hefty

- fine or loss of the firearm and a ban on obtaining or possessing any firearm for a specified period of time.
4. Increase penalties for anyone possessing, brandishing or using a firearm during the commission of any crime to a 30 year sentence. Anyone who fires or kills another person during the commission of a crime should receive a sentence of life without parole.
  5. Increase obligatory at-home storage and transportation requirements for all non-personal safety firearms such as shotguns, hunting rifles and so on. These should require separate locked and secure storage for firearms and ballistic rounds. Personal safety firearms at home storage and transportation should also have strict requirements to help prevent number of accidental deaths that occur every year.
  6. Make "Active Shooter" and "Emergency Disaster" response training compulsory in all public buildings and for all public sector employees and require a one day training in these techniques every year.
  7. Harden all existing and new public buildings to include specific hardened entry points to rooms and refuge points to mitigate "Active Shooter" incidents. Also require specific emergency tools and equipment for staff and responders to use in the event of an emergency.
  8. Establish and train everyone on a communications protocol to provide accurate, timely and vital information to emergency first responders when a building is in a "lock down" or emergency disaster response mode.

We all share the desire, understanding and urgency to make changes that will help prevent another situation such as Newtown, CT. We have had too many such heart-breaking incidents in this country, and the time has come to address this situation and work towards a resolution. We will never remove every threat from those who may desire to do harm from whatever motivation drives them, but we may be able to severely limit the losses suffered when such a person acts upon their desires.

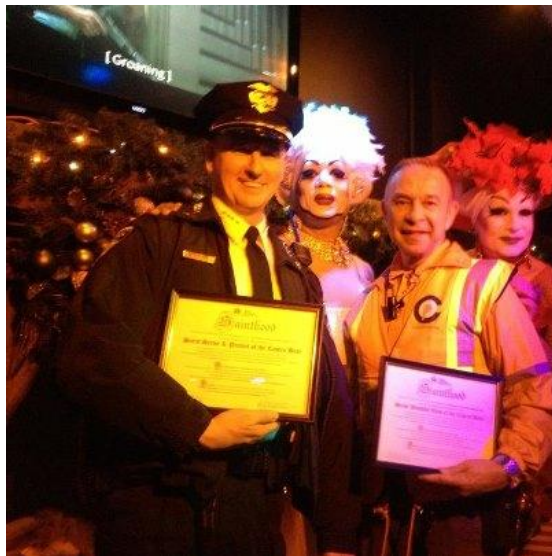
